

REQUIREMENTS FOR CERTIFICATION AS A MEMBER OF RANZCOG

1. Satisfactory completion of 48 months of ITP training.
2. Satisfactory completion of the MRANZCOG examinations.
3. Submission of signed Membership Application Form.
4. Recommendation for Membership by College Training and Accreditation (T&A) Committee and subsequent ratification of this recommendation by Council.
5. Payment of certification and subscription fees.
6. Signed Membership Declaration.

IMPORTANT NOTE: The onus is on the trainee to apply for Membership. Trainees who want an application prepared must contact the Training Services Officer at the College. Non-negotiable deadlines for application requests are: 1 February (for March Council), 1 June (for July Council) and 1 October (for November Council).

Upon completion of 48 months of ITP training, you need to submit the following to your Regional/NZ T&A Chair:

- Final six-Monthly Trainee Report for your ITP training, Clinical Training Summaries and Training Assessment Record (TAR), including the Certificate of Satisfactory Completion of Training (CSCT). Ensure that the CSCT has been signed by your ITP Co-ordinator;
- Logbooks for entire 48 months of training (Years 1 to 4).

Upon receipt of your Membership application:

- Check that all dates and details are correct. Your Membership date will be the date of completion of 48 months of satisfactory ITP training OR the date of successful completion of the MRANZCOG Oral Examination, if this is passed after completion of 48 months of satisfactory ITP training;
- Sign and return the application form to College House by the specified deadline.

Once your Membership application has been approved by the T&A Committee and College Council:

- You will be sent a letter advising you of the outcome;
- Successful applicants will receive an invoice for certification and subscription fees, and a Membership Declaration.
